## COMPLETION-CUM-OCCUPANCY CERTIFICATE

With reference to your notice of completion dated 22.04.2003 and 13.05.2015, I hereby certify that the building as per description below certified plans of Salwan Public School at Kondli Gheroli, Mayur Vihar Ph.III, Delhi-110096 whose LOP & Bldg. plans were sanctioned vide letter no. F13(111)/96/Bldg./226 dated 24.09.97 and completion certificate as referred to DUAC & CFO, the NOC has been approved on 16.06.15. The site has been inspected by field staff with reference to Building Bye-Laws in respect of the structural safety, fire safety, hygienic and sanitary conditions inside and in the surroundings and is declared fit for occupation.

The structural stability of the building is based on the certificate given jointly by the Owner/Architect/Structural Engineer along with one set of Structural Drawings, incorporating therein the provisions of Structural Safety as specified in the relevant prevailing IS Codes/Standards/Guidelines stated in the Government of India Notification bearing No.SO-248(E) dated 21.3.2001.
